

RURAL MUNICIPALITY OF STRATHCLAIR

BY-LAW #1-2008

Being a By-Law of the Rural Municipality of Strathclair fixing the indemnities and mileage of the members of Council for 2008, appointing them as Road Commissioners and setting their remuneration and allowance as such for 2008.

WHEREAS under Section 124 of the Municipal Act, the Council of the municipality may pass a by-law fixing the amount of indemnity and mileage; the terms and conditions therefore, and provide for the remuneration for authorized duties of Council.

AND WHEREAS the Council of the Rural Municipality of Strathclair deems it necessary and expedient to pass a by-law setting said indemnity and rates and making such appointments for the calendar year 2008.

NOW THEREFORE the Council of the Rural Municipality of Strathclair in open Council assembled enacts as follows:

1. That the Rural Municipality of Strathclair shall pay to each member of Council \$150.00 per day for attending meetings of Council. The Reeve shall also be paid \$75.00 per month indemnity above the \$150.00 per day for meetings. All members of Council shall be paid \$.80 per mile or \$.50 per kilometer, each way from their place of residence to the place of meeting such payments to be allowed only once for each meeting.
2. That each Councillor is hereby appointed Road Commissioner and gravel checker for the Ward they represent, and is hereby authorized to inspect and perform services in respect of highways or public works in their respective ward, and the Reeve of the municipality is authorized to inspect or perform work or services in respect of highways or public works throughout the municipality.
3. That the Rural Municipality of Strathclair shall pay to each member of its Council \$14.00 per hour for each hour actually and necessarily spent by him under authority previously given by resolution of the Council in the performance of such duties, work or services as he is required or authorized under resolution.
4. In addition to any other payment or indemnity provided in the by-law, the Council of the Rural Municipality may by resolution from time to time authorize payment by way of a lump sum amount not exceeding \$300.00 twice per year to be paid to the member of the Council carrying out the duties assigned to him of dispatcher for the said municipality, such sum to compensate such member for time and effort expended on behalf of the municipality, and which is not otherwise provided for.
5. That the Rural Municipality of Strathclair shall pay to each member of its Council \$.80 per mile or \$.50 per kilometer for each mile/kilometer actually and necessarily traveled by him in the performance of the duties, work or services to which the above paragraph #3 applies. Council members are allowed to claim the actual cost of purchased meals, when receipts are provided up to the following maximum amounts: Breakfast \$9.00; Lunch \$11.00; Dinner \$20.00; Daily limit \$40.00. Individual meal allotment will be used when meal costs are for less than one day.
6. It is specifically enacted that remuneration or mileage mentioned in paragraph #3, 4, and 5, hereof shall not be payable until an account showing the work or services performed, verified by Statutory Declaration, has been filed with the Administrator and the payment thereof authorized by resolution of Council.
7. That this by-law shall be effective as of and from January 1, 2008 to December 31, 2008.
8. That By-Law No. 1-2007 of the Rural Municipality of Strathclair is hereby repealed.
